TRAILS: Flat, sandy, and barefoot friendly through the precious longleaf ecosystem. Novice and CP will ride approximately 18 miles Saturday and 14 miles Sunday. Open will ride approximately 29 miles Saturday and 22 miles Sunday.

MEETINGS AND MEALS: All meals will be on your own. Volunteers will be provided breakfasts and brown-bag lunches; dinners by arrangement with management. There will be a silent auction and/or raffle to support the ride.

NOTES: Florida law requires current proof of negative Coggins, which must be shown to the forest ranger on arrival. Florida law also requires a health certificate for all livestock entering the state.
